What about retained ownership from fall 2015 calf crop?

• Salina, KS 1/25/16 situation:

-Sell 800 lb yearlings on 5/20/16 (\$151.22)

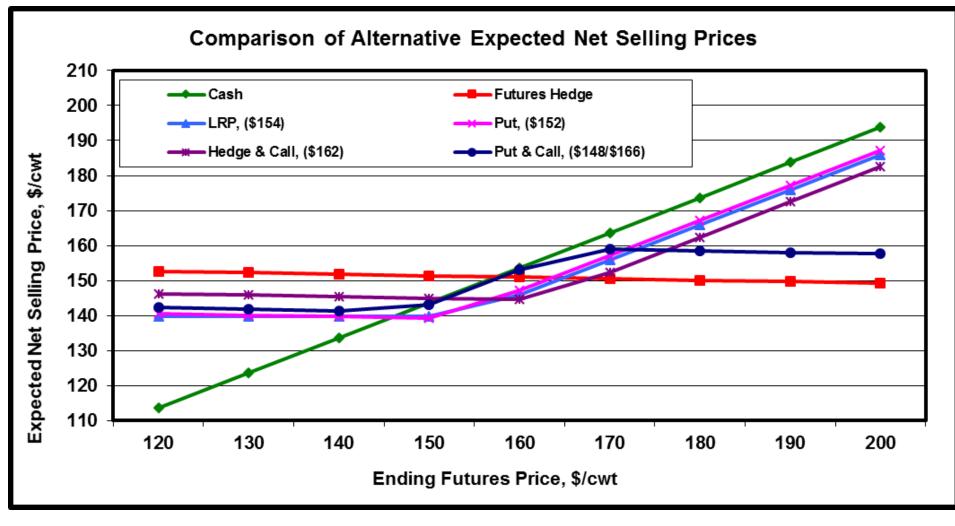
- Considering price protection on May sale
 - Or for stocker/feedlots consider for buy in May

– USE: FeederCattleRiskMgmtTool.xlsx

- Case of 60 hd @ 800 lbs =
 - Compare alternatives:

a) 60 hd on LRP, b) 1 FC Futures Contract (+/- 63 hd per contract), c) 1 FC Options Contract or d) Cash

- MAY FC: \$157.50 & Exp. Basis: -\$6.28 (Exp. Cash = \$151.22)
- LRP Coverage Price: \$154.02 & Premium: \$7.82
- MAY Put Option @ \$152.00: \$6.15 premium

• Salina, KS 1/25/16 situation:

-Sell 550 lb calves on 9/16/16 (\$169.44)

- Considering price protection on Sept sale
 - Or for stocker/feedlots consider for buy in Sept

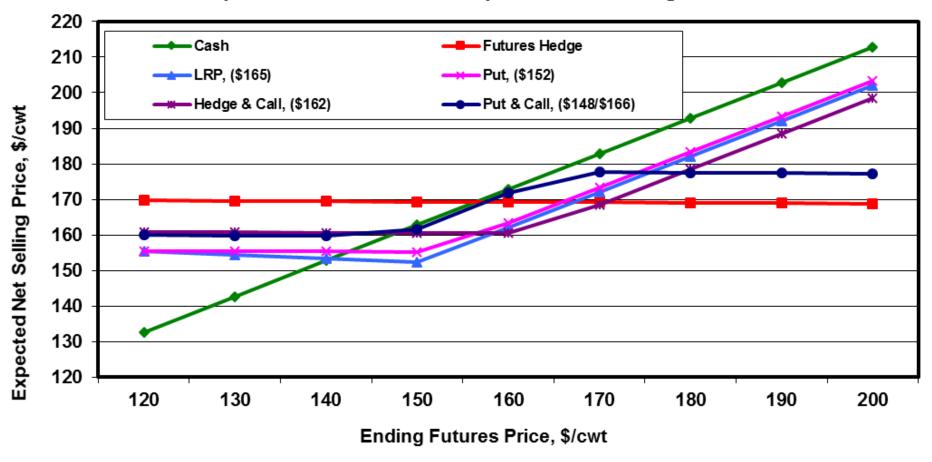
- USE: FeederCattleRiskMgmtTool.xlsx

- Case of 90 hd @ 550 lbs =
 - Compare alternatives:

a) 90 hd on LRP, b) 1 FC Futures Contract (+/- 91 hd per contract), c) 1 FC Options Contract or d) Cash

- SEPT FC: \$156.675 & Exp. Basis: \$12.76 (Exp. Cash = \$169.44)
- LRP Coverage Price: \$165.34 & Premium: \$10.736
- SEPT Put Option @ \$152.00: \$9.35 premium

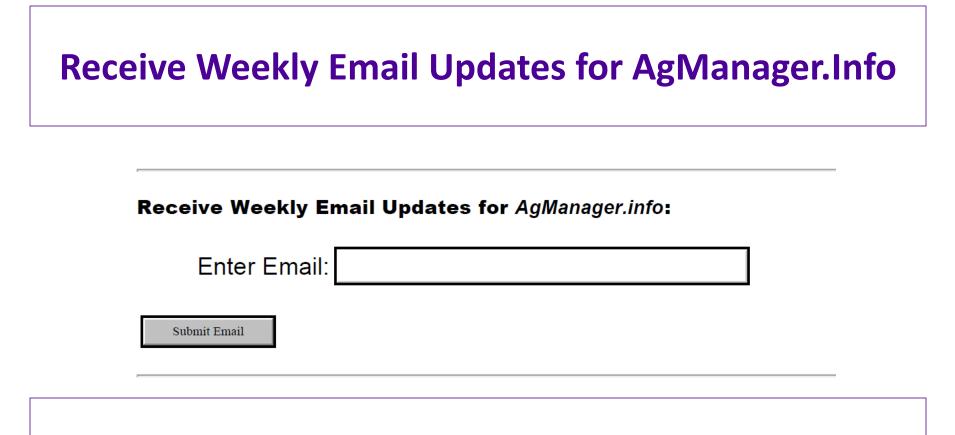
