Program Speakers

KC Olson: KC is a professor of range beef cattle nutrition and management. He is actively involved in the undergraduate and graduate teaching mission at KSU and takes great pride in the privilege of helping to train the next generation of Great Plains ranchers and farmers. KC's research program is designed to address questions that directly affect beef industry profitability. Specific areas of research include: nutritional management of cattle grazing native range; management of invasive range plants; effects of calfhood nutritional management on carcass quality and value; and factors influencing grazing behavior.

KC holds advanced degrees from Kansas State University and North Dakota State University. Prior to coming to KSU, he was on the faculty at the University of Missouri -Columbia. KC is active in the American Society of Animal Science, the Society for Range Management, the American Registry of Professional Animal Scientists, and the American College of Animal Nutrition.

Charlie Lee: Charlie completed a B.S. degree in 1975 at Kansas State University in Wildlife Biology. After several years of business and being involved with the family farm and feedlot he returned to Kansas State where he completed a M.S. degree in 1988 in Animal Science. He previously worked for Kansas Department of Wildlife and Parks for 6 years directing private land wildlife management programs and Farm Bill conservation issues. Charlie was first employed as an extension assistant and now as Extension Specialist, Wildlife. Responsibilities include conducting a statewide program in wildlife damage control, wildlife enhancement on private lands, youth outdoor environmental programs, and aquaculture. Current areas of interest include prairie dog and cattle interactions, bird damage control at feedlots and rodent damage in conservation tillage systems.

Barry Flinchbaugh: Dr. Flinchbaugh represents the agricultural community through his active participation in the development of U.S. agricultural policy. His service on numerous national task forces, boards of directors, and advisory groups has allowed him to provide input on domestic food and agriculture policy. He served as Chairman of the Commission on 21st Century Production Agriculture authorized in the 1996 FAIR ACT.

LeRoy Burk: LeRoy Burk is a Certified General Appraiser and resident of Neosho County. He has been county appraiser for Neosho, Labette and Montgomerty Counties. He has been active in testifying on behalf of the Neosho County Concerned Citizens for Property Rights concerning House Bill No 2273. He has done extensive study on property values and wind turbines.

Glynn Tonsor: Glynn Tonsor joined the K-State Agricultural Economics faculty as an Assistant Professor in March 2010. He obtained his Ph.D. from K-State in 2006 and was an Assistant Professor in the Dept. of Agricultural, Food, and Resource Economics at Michigan State University from May 2006 to March 2010. Tonsor's current efforts are primarily devoted to a range of integrated research and extension activities with particular focus on the cattle/beef and swine/pork industries. His broader interests cover aspects throughout the meat supply chain ranging from production level supply issues to end-user consumer demand issues.

Mykel Taylor: Mykel Taylor joined the Kansas State faculty in 2011 as assistant professor of agricultural economics with a major appointment in extension. Her areas of focus include food safety and consumer demand, grain marketing, and agricultural land values. Taylor was an assistant professor and extension specialist for the School of Economic Sciences at Washington State University. Dr. Taylor has been the education coordinator for the Kansas Society of Farm Managers and Rural Appraisers for the past five years. **Beth Davis:** Dr. Davis is an internist with clinical interests involving immunologic, neurologic, respiratory and gastrointestinal diseases affecting horses. She received her DVM from the University of Florida before coming to Kansas State to earn her PhD. Specific areas of research include immunology as it relates to effective vaccine strategies in horses and influences on the immune system, clinical pharmacology involving commonly used drugs in equine case management and evaluation of the pathogenesis of EHV-5 and related disorders.

Mike Beam: Mike Beam was appointed secretary of the Kansas Department of Agriculture by Governor Laura Kelly in January 2019 and confirmed in April. Beam came to KDA following 38 years of experience in association management for the Kansas Livestock Association. He has served as the Executive Director of the Ranchland Trust of Kansas, an affiliate of KLA, for 15 years. He has dedicated his career to assisting farmers and ranchers to advance their policy and public relations needs and in building highly visible, responsive and respected organizations. In his role at KLA he participated and led coalitions in strategizing and implementing legislative and regulatory initiatives.
