


Introduction

- Since 2020,* producers with base acres make an annual selection between Agricultural Risk Coverage (ARC) or Price Loss Coverage (PLC)
 - Several tools on AgManager inform this choice: https://agmanager.info/ag-policy
- Producers using PLC (not ARC**) can purchase SCO (Supplemental Coverage Option) insurance.









Objective

- Producers typically compare ARC and PLC instead of ARC and (PLC + SCO)
- SCO use has been low, but is growing
- This study considers
 - Historic payouts of these programs
 - Historic price guarantee







PLC and ARC Refresher

- PLC provides payouts when prices are lower than the effective reference price.
- ARC provides payouts when actual revenue is lower than the revenue guarantee.
 - Types: Individual (ARC-IC) or County (ARC-CO).
 - This study focuses on ARC-CO only







PLC Refresher

- A PLC payout is triggered when the effective price or marketing year average (MYA) price* is lower than the effective reference price:
 - PLC "payout rate" = effective reference price – MYA price
 - Effective reference price¹ = prices for covered commodities set in the Farm Bill²





PLC Refresher

- · If triggered
 - PLC payout = 85% X base acres X payment yield X payout rate
 - Payment yield = the farm's established yield







ARC Refresher

- ARC-CO payout is triggered when actual county revenue is lower than the county guarantee.
 - ARC County Guarantee = 86% X benchmark revenue
 - Benchmark revenue = Olympic average* price X Olympic average* yield
 - Actual revenue = MYA price** X actual county yield
 - ARC maximum payout (max) = 10% of benchmark revenue







ARC Refresher

- · When ARC-CO payout is triggered
 - ARC payout rate = county guarantee actual revenue, up to the maximum payment*
 - ARC payout = 85% X base acres X payout rate
- Some counties have both irrigated and non-irrigated payouts, while others have combined (all) payouts.






When the maximum payout < (county guarantee - actual revenue), the maximum payout is allocated to that county.



SCO Refresher

- Producers who choose PLC can purchase SCO:
 - SCO increases coverage to 86% of expected revenue
 - This study focuses on producers with underlying RP insurance
- SCO expected revenue = county/area expected yield X the higher of (1) pre-planting futures price or (2) harvest price








Introduction (SCO)

- SCO payment triggers if Actual county revenue < 86% of expected county revenue
- Actual county revenue = actual county/area yield X harvest price







Approach

- Compare SCO, ARC, and PLC payouts from 2015-2022 for corn, grain sorghum, soybeans, and wheat
- PLC based on actual payment rates
- ARC payouts are computed using FSA formulas
 - 2022 ARC irrigation-status designations applied to all previous years
 - Payouts for counties with different prior (2015-2021) designations are computed using:
 - Insured acres and yields for counties with combined ARC.
 - Irrigated and non-irrigated SCO yields for counties without combined ARC.
- Net SCO payouts are also estimates based on
 - 75% underlying coverage level for Revenue Protection (RP) insurance, which is commonly used in KS and makes SCO more comparable to ARC
 - Assuming a representative producer has yields (APH) equivalent to county yields
 - RMA formulas for premium rates
 - Net SCO = net indemnities or payouts = estimated indemnities minus estimated premium



ARC payouts were higher than PLC for irrigated corn and lower for non-irrigated corn

- On average, ARC payouts were larger for irrigated corn than to Net SCO+PLC.
- For non-irrigated corn ARC* payouts for corn were the highest for combination SCO and PLC

Average Annual Corn Payouts for 79 Kansas counties, 2015-2022




RMA data were used for ARC and SCO payout calculations. This analysis is based on counties with ARC, PLC and SCO data. PLC has no irrigation status.



Sorghum had high average PLC payouts

- On average, net SCO + PLC offered larger payouts for both irrigated and non-irrigated sorghum
 - Driven by large PLC payouts.

Average Sorghum Payouts for 48 Kansas counties, 2015-2022





Annual per acre payouts for each county and commodity were averaged for the study period. **Counties with Combined ARC are examined later.

ARC paid more than SCO for irrigated soybeans and less for non-irrigated soybeans

- There were no PLC payouts in this period.
- For irrigated soybeans, ARC* payouts were higher than net SCO+PLC
- For non-irrigated soybeans, SCO payouts were slightly higher than ARC payouts.



RMA data were used for ARC and SCO payout calculations. This analysis is based counties with ARC, PLC and SCO data. PLC has no irrigation status and payouts.

Average Annual Soybeans Payouts for 53 Kansas







Average PLC payouts for sorghum were the largest until 2020

- Average PLC payouts for all commodities except soybeans peaked in 2016 for selected counties.
- There were no PLC payouts for soybeans from 2015-2022








Average net SCO net payouts were high for most crops in 2022

Average Net SCO by Crop and Irrigation Status for all selected Kansas counties*, 2015-2022







Average Net SCO and PLC Payouts by Crop and Irrigation Status for all selected Kansas counties, 2015-2022





Irrigated Corn: Difference between Net SCO + PLC and ARC from 2015-22









Irrigated Wheat: Difference between Net SCO + PLC and ARC from 2015-22



Non-Irrigated Sorghum: Difference between Net SCO + PLC and ARC from 2015-22








Non-Irrigated Corn: Difference between Net SCO + PLC and ARC from 2015-22





Non-Irrigated Soybeans: Difference between Net SCO + PLC and ARC from 2015-22






Non-Irrigated Wheat: Difference between Net SCO + PLC and ARC from 2015-22








Non-Irrigated Corn: Net payouts across 25 Kansas counties, 2015-2022





Some counties do not have data in all years. For example, Chautauqua County has 7 years data. * The frequency difference is influenced by SCO: Non-Irrigated SCO estimates are missing for Southwestern Kansas, resulting in fe difference is influenced by SCO: Non-Irrigated SCO estimates are missing for Southwestern Kansas, resulting in fewer frequencies than Irrigated SCO.



Average annual PLC and ARC for corn were similar for combined ARC counties

- Net SCO payouts for irrigated corn were negative
- On average, net SCO + PLC offered the largest payouts to non-irrigated
- · ARC had marginally higher payouts than PLC, but SCO + PLC had higher payouts than ARC






SCO+PLC offered the highest average annual net payouts for wheat

Net SCO + PLC offered larger the largest payouts for irrigated and non-irrigated wheat, largely due to PLC payouts being much higher than ARC payouts



Sorghum average PLC payouts much larger than combined **ARC**

- Net SCO + PLC offered larger payouts for irrigated and non-irrigated sorghum from 2015 to 2022.
 - Driven by large PLC payouts.



Net SCO payouts higher than ARC for non-irrigated soybeans in combined ARC counties

Net SCO + PLC were larger than ARC for non-irrigated soybeans, due to higher SCO payouts (zero PLC payouts)

 ARC payouts were larger than Net SCO+PLC for irrigated soybeans

Average Annual Soybeans Payouts for 41 Kansas counties, 2015-2022*





We estimate annual per acre combined ARC payouts by county and then average all (selected) KS counties. This approach may overweight payouts in counties with lower acreage of a particular commodity.






Average PLC payouts peaked in 2016




Average Net SCO by Irrigated Crop for Selected Kansas counties*, 2015-2022








Net SCO payouts peaked during the 2022 drought for most crops



Average Net SCO and PLC Payouts by Irrigated Crop for Selected Kansas counties*, 2015-2022














Corn Guarantee Prices by Program


Soybeans Guarantee Prices by Program








Wheat Guarantee Prices by Program

Conclusion

- Average net SCO payouts for Kansas from 2015-2022 were positive, except for irrigated corn
 - Net SCO payouts were highest in 2022 due to extreme drought conditions
 - Net SCO payouts were higher than ARC in 2022
- · PLC never paid out for soybeans
- PLC paid out the most in initial years when prices were lower
 - PLC was more favorable than ARC for wheat and sorghum
- The difference between average ARC and PLC was typically larger than SCO net payouts
 - Non-irrigated corn in counties with combined ARC yields was one exception





Caveats

- Current year guarantee and a producer's risk tolerance may also play a role in ARC, PLC, and SCO decisions.
- This study does not consider average payouts for producers who switched between policies or otherwise considered current guarantees and market conditions when selecting between ARC and PLC





Implications

- The difference between the current SCO and ARC guarantee is an important consideration in the ARC vs PLC decision

 o Price and revenue protection provided by each product will vary over time
- Historic performance doesn't determine future performance
 Provides information on payouts during different market and yield conditions





Looking forward

Analyze difference in yield guarantee, triggers, and prices in determining difference in SCO vs ARC payouts Assuming no major changes in Title 1 programs, add SCO analysis to existing Agmanager.info ARC and PLC comparison tools

Formula Sheet

- SCO/acre= RMA formula
- PLC/acre=0.85*[Reference price –max(Annual National average market price, Market Assistance loan rate)]

ARC guarantee=0.86*benchmark revenue; difference=ARC guarantee-actual revenue; maximum= 10%*benchmark revenue If difference ≤ 0 then payout=0 If $0 < difference \leq maximum$, then payout=difference, then payout=difference*0.85
